RE: ACCREDITATION AND CHARTER AFFILIATION AGREEMENT

This accreditation and affiliation is between Ballsbridge University Commonwealth of Dominica, hereby known as the 'University' established by International Agreement and chartered by Dominica' and the Chartered International Da Vinci University established in Delaware United State of America known as 'Accredited Affiliated Institution and Institutional Body within Ballsbridge University Alliance system in USA and worldwide'.

PART1

The university body and affiliated Institution shall follow the guidelines as follows:

Article 1. The Authoritative Body, board of quality standards a member of international quality assurance agency for higher education and Ballsbridge University shall collaborate with the Chartered International Da Vinci University (CIDVU) in Delaware/international in the provision and recognition of accredited qualifications worldwide.

Article 2. All Qualification and certification of Chartered International Da Vinci University (CIDVC) Shall be recognized by the Board of quality standards and Ballsbridge University within Ballsbridge university consortium of universities as an institution and recognized university alliance and students of Chartered International Da Vinci University and Affiliated institutions can receive statement of Comparability to the equivalent of EQF standards from Board of Quality Standards Cyprus Office.

Article 3. Institutions approved by Chartered International Da Vinci University can be admitted as accredited Institutional Members of BQS and BU without further scrutiny by BQS they can only pay accredited membership fees to BU systems Cyprus Office if applicable.

Article 4. CIDVU or affiliated institutions of CIDVU will optionally eligible to attend BU world convocation hosted in India and other countries or host optional BU or joint convocation in USA or other countries.

Article 5 BQS and Ballsbridge University will be eligible to display CIDVU Logos as accredited alliance Members or Bodies and CIDVU will be eligible to display Logo of BQS and Ballsbridge University as accredited Alliance Member.

Article 5. In this partnership students from CIDVU can request for qualifications based on studies done with CIDVU and Pay appropriate certification fees for certificate, diploma, Bachelors, Masters, Doctorates, Post doctorate in several fields to BU office or BU representative offices worldwide. BU students can also request for CIDVU Qualification

based on work done at Ballsbridge University Centres and online worldwide and pay appropriate fees to CIDVU.

Article 6. Senior Members of CIDVU can be optionally be qualified for Fellowship of Board of Quality standards (FBQS) or Ballsbridge University (FBU) BQF/EQF Level 8 doctoral level.

Article 7. Recognized University in USA/Ghana approved by state of education board and accredited or equivalent accrediting agencies in USA/Ghana will be recommended in the data base of the Board of quality standards for worldwide reference.

Article 8. address of CIDVU is also address of BU and BQS Consortium in USA/Ghana as part of the university consortium systems and will be listed in the directory.

Article 8a. the west coast university will be regulated by the BQS GAAP:2011 standards of Board of quality standards where criteria to grant accredited degrees within the consortium is as follows: Associate degree at BQF/EQF level 4 is two years of studies, GAAP 60 credits-HND at BQF/EQF level 5 and duration 3 years 90 GAAP credits- Bachelor at BQF/EQF level 6 and 4 years duration and 120-180 GAAP credits- Masters at BQF/EQF Level 7 and minimum 1/2 year duration and 45-60 GAAP credits- Doctorate/PhD BQF/EQF Level 8 and duration 3 years and can also be completed in 2 years depending on subject exemptions and 60 GAAP credits.

Article 8c. the Chartered International Da Vinci University will be listed in the international directory of accredited institution within the BQS and Member of IATU.

Part II

Article 9. This Accreditation and charter affiliation agreement come into force from the date of its signing and shall be effective unless one of the parties notifies the other party in writings of its intention to Cancel the Accreditation. This accreditation is reciprocal in nature.'
